Selected as the result of a national search, I am the founding dean of Cleveland State University's Mandel Honors College, home to 550+ students. I have primary administrative responsibility for student recruitment, admissions, student life, and curriculum. I supervise two administrative staff positions, two staff advising positions, and a half-dozen part-time instructors. I manage a budget of ~\$600,000. In spring 2017 I was awarded a \$2 million grant to create a pipeline program with Cuyahoga Community College's Mandel Scholars Academy.
